

2010 MB400 Mono MFP Sweepstakes Terms and Conditions

1. Description of Sweepstakes Offer. The 2010 MB400 Mono MFP Sweepstakes ("Sweepstakes") is sponsored by Oki Data Americas, Inc. located at 2000 Bishops Gate Blvd. in Mt. Laurel, NJ 08054 ("Sponsor"). Sponsor will award one (1) prize to one (1) winner, selected in a random drawing of all eligible entries received during the Promotional Period. Only one (1) prize will be awarded across all participating web sites and all creative representations. The prize for which an entrant is eligible depends on the creative representation through which the entrant entered the Sweepstakes. 2. Promotion Period. The Sweepstakes promotion begins February 18, 2010 at 12:00:00 pm Eastern Time ("EST") and ends March 18, 2010 at 11:59:59 am EST (the "Promotion Period"). All entries must be received during the Promotion Period. One (1) winner will be drawn on or about the 10th day of the month following the close of the Promotion Period.

3. How to Enter. To enter online, complete the online survey form provided through the <http://www.okidata.com/mkt/html/nf/mb400.html>. By completing the online survey form, you are agreeing to be notified by e-mail if you are the winner of the Sweepstakes. All parts of the entry must be filled out correctly; incomplete, illegible, misdirected entries, or entries received through impermissible or illegitimate channels are void. Only one (1) entry per person or e-mail address is permitted regardless of method of entry unless otherwise noted by Sponsor. Duplicated entries will be voided. All entries become the property of Sponsor and will not be returned.
